Welcome

It has been an exciting year for the Café
Africa Network as we see farmers benefitting
both from higher world coffee prices
and increasing production in Tanzania,
Uganda and DR Congo. Coffee revenues
are increasingly significant to farmers
and exporting nations. Uganda is likely to
become only the second African nation (after
Ethiopia) whose annual coffee exports will
exceed \$1 billion, with Tanzania approaching
\$500m. This is a far cry from the nadir of late
2001 when arabica prices were 40 cents per lb
(today 340 cents). Robusta, now at \$5,500 per
mt was at \$1,100 per mt as recently as 2020.

Higher prices and increasing production make coffee a more attractive crop for younger people considering whether farming is a worthwhile future for them. Café Africa Tanzania's programme (Sustainable Rejuvenation of Coffee Production in Kagera) supported by JDE and the Tanzanian Government emphasises the training of young people. In Uganda the Youth for Coffee Programme is a Collective Action Initiative of the Global Coffee Platform (GCP) and Café Africa Uganda (CAU). The Code-P project in Southern Tanzania, which concluded successfully in 2024, reached some 12,980 young women and men over its four-year span.

The implementation of the European Union Deforestation Regulation (EUDR) has been postponed until January 2026. However, the Café Africa Network has been fully engaged in ensuring that producing countries are ready. CAU was selected as the Coordination Unit for the EUDR and CSDDD National Compliance Action Plan. CATZ and CARDC have both supported national regulators in their preparations for EUDR.

The regular work supporting the coffee industry by all CA colleagues continues. CAU continues to host the Secretariat to the National Steering Committee of the Uganda Coffee Platform. CATZ again provided the Secretariat for the National Coffee Steering Committee. I continued to chair the Technical Committee of the Global Coffee Platform (GCP) as well as its Pesticide Action Group which updated the list of prohibited and phase-out pesticides for coffee (see globalcoffeeplatform.org).

We all wish to thank and pay tribute to Reint Bakema who has stepped down as Executive Director of CAU. He and his successor Samson Emong have worked tirelessly over many years to strengthen CAU as a reliable supporter of Uganda's coffee farmers.

We also honour Gill Brentford, the founding Chair of Café Africa, who died in October 2024. It was Gill who encouraged me into the coffee business 39 years ago. She was an inspiration to all who had the honour of working with her across so many fields (health, faith, development, peacebuilding, women in leadership and more). She herself was inspired by her Christian faith and supported in her work by her family to whom all of us in the Café Africa Network send our deepest sympathy.

Our heartfelt thanks go to all our colleagues on the boards of the Café Africa Network and the staff in Uganda, Tanzania and DR Congo. We also thank all our partners in government, the private and not-for-profit sectors. Above all we thank farming families for their work in producing such fine coffee for the enjoyment of the world.

Café Africa Uganda

Café Africa Uganda (CAU) has continued to support Uganda's coffee sector nationally, and through the coordination of an Initiative directly targeting the skills and knowledge of young people and smallholder coffee farmers.

Youth for Coffee in Uganda - GCP Collective Action Initiative (YfC-CAI)

Since 2022 Café Africa Uganda (CAU) has been coordinating the Global Coffee Platform Collective Action Initiative: "Ugandan Youth for Coffee: Developing Prosperity through Rehabilitation & Rejuvenation."

This 5-year Initiative aims to train 150 private Youth Coffee Service Provider Business Units (YCSP-BUs) to carry out rehabilitation and rejuvenation (R&R) of old coffee trees at 30,000 individual coffee farms (up to 50 trees per farm) in ten operational areas of Uganda.

The Collective Action Initiative facilitates innovation, entrepreneurship, employment and effective service delivery across the coffee value chain. Through its coordination of the Initiative,

CAU has been instrumental in promoting youth skills and financial empowerment as driving forces in the coffee sector.

Implementing Partners (IPs)

In 2024, two new Implementing Partners, BUCADEF II (Buganda Cultural and Development Foundation under the Buganda Kingdom) and Mountain Harvest SMC Ltd joined the Initiative, bringing the total number of IPs to seven.

The IPs operate in 20 Districts of the Central, South-Western and Mt. Elgon regions of Uganda.

IPs are tasked with identifying and selecting trustworthy young people from their communities to establish coffee service provision businesses (YCSP-BUs). Youths must be aged between 18 and 30, have a minimum level of education, openness to learning, a passion for agriculture (coffee) and community service, and a focus on ensuring that at least 40% of participants are female.

25 YCSP-BUs were established in 2024, 10 of which belong to Mountain Harvest. While the previous IPs operate in Robusta-growing areas, Mountain Harvest (a private coffee company) works in the Arabica coffee-growing region of Mt Elgon in Eastern Uganda.

YCSP-BU Training

Training for the YCSP-BUs covers coffee agronomy (with a focus on stumping), soil and water conservation, sustainable

coffee production, agroforestry, business development skills, ICT and adult facilitation skills. Four training blocks are spread over a period of one year. The completion rate for Cohorts 1 and 2 (whose training has now finished) was 94% and 98.3% respectively.

YCSP-BUs are equipped with a tool kit comprising a smart phone (for on-farm data collection), assorted tools and 10 litres of disinfectant to prevent spread of Coffee Wilt Disease (CWD).

Delivery of Coffee Farm Management Services to Farmers

In 2024, Cohort 1 and 2 YCSP- BUs delivered climate-smart R&R and agroforestry demonstrations/training to 5,322 (2,015 female) farmers, leading to 268,976 coffee trees being rehabilitated.

For the Cohort 2 trained farmers, 1,940 (718 female) received at least 5kg of organic fertiliser to facilitate tree recovery after rehabilitation. Fertiliser demonstrations were conducted on 25 coffee trees, with positive feedback received from farmers when follow-up was carried out.

The youth receive commission-based compensation for each of the services provided (farmer registration, stumping and pruning, post stumping sucker selection and fertilizer application). So far, services that have fetched the highest income have been stumping and pruning (70%) and establishment/gap filling (18%).

Distribution of Shade and Agroforestry Tree Seedlings

During 2024, four agroforestry tree nurseries were established in Cohort 2 operational areas. From these, 124,900 seedlings were distributed to farmers. Most seedlings were provided free of charge.

Impact Study on R&R, Production and Income (Living Income Study)

A GAPs (Good Agricultural Practices)
Adoption and Living Income survey was conducted in 2024, with 305 respondents (48% female). The survey revealed that coffee contributes 70-72% of household income, with 56% of farmers adopting at least one GAP, such as stumping, pruning,

intercropping, and weed control.

Adoption of R&R practices was 12% higher among smallholder farmers with less

than two acres than farmers with more than 2 acres. 90% of farming households earn below the annual Living Income (LI) benchmark of UGX 18 million (approx. USD 3,600), with an average LI gap of 52% for non-adopters and 43% for adopters.

The survey also revealed that while GAPs adoption increases production costs, it provides an additional average USD 338 annually through higher yields, offsetting initial investments.

Such outcomes reflect the vital need for interventions like the YfC-CAI, which has the potential to positively affect the incomes of both the young people who train as business service providers, and the farmers who employ their services.

Support for the Coffee Sector

CAU has continued to act as secretariat to the National Steering Committee (NSC) of the Uganda Coffee Platform, which held monthly meetings throughout 2024. CAU was instrumental in securing funding from aBi-Development, the European Union Delegation to Uganda, and GIZ, towards implementing the Country Plan.

In March 2024 CAU organised two Public-Private Partnership (PPP) events in Rwampara and Masaka districts, with the theme "Agroforestry for Sustainable Coffee Production and Improved Household Income". Over 500 key public and private stakeholders attended. Funding has been secured from the European Union Delegation to Uganda, and GIZ, to conduct more PPP dialogues in 2025.

A major role for CAU has been to act as the Coordination Unit (CU) for the **EUDR and CSDDD National Compliance** Action Plan, with financial support from aBi-Development. Key activities included establishing an office, engaging stakeholders and coordinating the work of consultants. By December 2024, 412,129 farms/polygons out of the targeted 912,906 had been mapped. The CU is also developing Terms of Reference for a central data warehouse, and fostering partnerships with organisations such as the EU Delegation to Uganda, Food and Agriculture Organisation (FAO), the International Trade Centre (ITC), MAAIF, and cultural and religious institutions.

CAU also coordinated the EUDR and CSDDD Taskforce and was involved in the production of a podcast to explain the opportunity for Uganda to be declared deforestation-free.

Café Africa Tanzania

2024 marked the completion of two highly successful projects that contributed to significantly-increased coffee production in western and southern regions of Tanzania. Café Africa Tanzania (CATZ) played a key role in both projects, drawing on 15 years' experience in encouraging partnership working, to the benefit of small-scale coffee farmers.

Sustainable Rejuvenation of Robusta Coffee Production in Western Tanzania (Kagera),

2019-2024

Aim

The project aimed to increase coffee production and productivity and to improve farmers' livelihoods, through specific interventions at farm level, by strengthening the capacity of the agricultural extension services in Kagera region through both Local Government and the AMCOS.

CATZ was the implementing partner, with the project funded by JDE Peet's.
CATZ utilised its 'stakeholders' partnership approach', drawing together the experiences and resources of all involved: the Kagera Regional Secretariat (RAS office), the Tanzania Coffee Board (TCB), Tanzania Coffee Research Institute (TaCRI), Cooperative Unions (KCU and KDCU) – which brought together 250 AMCOS across the entire region - as well as Ngara farmers.





Kagera Coffee Production Increases

The project has contributed towards increased coffee production in the Kagera region: **52,099 mt** of coffee dried cherries in 2024/2025 compared with **27,060 mt** in 2019/2020




Project Emphases

Sustainable and innovative farming practices that not only improve crop yield but also enhance water and soil conservation, biodiversity, carbon sequestration and the flavour profile of the coffee.

Training of Extension
Agents, with initial

offered at district, ward and

is based on the Tanzania National
Coffee Sustainability Curriculum.

 Encouragement of young people and women to train as Extension Officers, or become fully involved in coffee production.

- Stumping old coffee trees. Such has been the success of stumping as a cost-effective alternative to seedling multiplication, that the TCB has initiated a pilot study of similar initiatives in Ruvuma, a leading region in Arabica coffee production.
- Use of demo plots to demonstrate the improvements to be gained from various sustainable techniques.
- Financial inclusivity, with tailored financial products for farmers, enabling better access to mobile payment systems and encouraging the formation of Village Savings and Loan Associations (VSLA).



The establishment of a project steering committee was crucial for sustaining these developments. The steering committee plans to continue, facilitated by the TCB.

Looking ahead

Adapting to changing weather patterns remains crucial. Increasing the promotion of climate-smart agricultural techniques, offering more training on sustainable practices, and improving farmers' access to climate information and risk management tools are essential steps to strengthen the resilience of the coffee sector.

In light of this, Sustainable Production of Robusta Coffee in Western Tanzania – Phase II will build on lessons learnt so far.

Coffee Development Project (CODE-P) in the Southern Regions of Tanzania

Coffee Development Project (CODE-P) in the Southern Regions of Tanzania 2020-2024

Aims

The project aimed to strengthen smallholder coffee cooperatives, to support the production, processing and trading of coffee in three regions of southern Tanzania: Ruvuma, Mbeya and Songwe (two districts in each region). To stimulate trade-led economic growth by strengthening the competitiveness of smallholder coffee producers in those regions, promoting investment and job creation along the coffee value chain.

CATZ was one of five project partners. The project was funded by the EU (80%) and the Swedish Development Agency SIDA (20%) through Vi Agroforestry, the lead partner.

Policy and Advocacy Work

Café Africa Tanzania continues to create and maintain dialogue between public and private coffee sector stakeholders, bringing the voice of the smallholder farmer to the table.

Historically CATZ was instrumental in supporting the TCB to establish the annual National Coffee Conference which has eight Zonal Stakeholder platforms reporting to it. These platforms are supported by the National Coffee Steering Committee, for which CATZ continues to serve as Secretariat.



Karawa Coffee Project

CARDC worked with nearly 2,200 smallholder farmers to rejuvenate coffee cultivation and trade around Karawa, in RDC's Ubangi region. The project ran in partnership with the Covenant Church





of Congo (CEUM), funded by the Paul Carlson Partnership.


